We are writing to you to express our concerns about the impact of the repeal of section 52 of the Copyright Designs and Patents 1988, as amended and revised. In particular, the reduction in the transitional period from 5 years to less than 4 months will have a severely detrimental effect on the activities and services of libraries, archives and museums. This will result in costs, confusion and poor services.

In this issue, LACA and Universities UK (UUK) strongly support the position of the Publishers Association, the V&A and the Society of Authors.

Of particular relevance, we would like to highlight the following likely scenarios if the transition period for the repeal of Section 52 remains at less than 6 months:

- 1. Libraries and Archives will need to take images of works that they have digitised off line. Reviewing all the images that may be impacted by the repeal will take time and resources which we can ill afford in such a short period of time.
- 2. Libraries may need to take books off shelves and out of circulation in instances where images are infringing. This will take time and is highly impractical if books are out on loan.
- 3. University libraries may need to find alternative books for courses which have already started, or find themselves having to redact articles which the CLA are informed contain infringing items. This will disrupt learning and cause unreasonable pressures on limited staff time particularly if alternatives are required during the academic year.
- 4. Museums will need to remove online images which themselves may have been licensed out under Creative Commons Licences.
- 5. Museum shops and retail outlets will need to remove items from shelves.
- 6. Planned commercial activities across the cultural heritage sector using images impacted by these provisions may be too far down the line and the resulting products

On the basis of these, this recommended change to the transition period will be a disaster and LACA and UUK implore you to rethink it.
